#### Battle River Coal-fired Power Plant RE: Fly Ash:

Concerns have been expressed with the Battle River coal-fired power plant located in the SW ¼ of Section 29 Township 40 Range 15 West of the 4th Meridian (approximately 16 km southwest of Forestburg), operated by Alberta Power (2000) Ltd., as it is to include new air emission sources from the dry sorbent storage bins and a small increase in wastewater volumes for cleaning the bins. Concerns were raised with

safety due to the use of Sodium Chlorate and that fly ash is being buried in the old mine area located in the County of Stettler.

A notice was printed in the Stettler Independent which indicated that an application has been made to Environmental Protection and Enhancement Act being:

The coal mine, operated by Prairie Mines & Royalty Ltd., is to accommodate the disposal of sorbent from the power plant for SO2 reduction. The sorbent (sodium bicarbonate) and fly ash material will continue to be disposed of in ash disposal locations. Sufficient reclamation material will be salvaged to cover disposal materials consistent with current approval requirements. The operation is located in Sections 1, 2, 10-15, 22-27, 34, 35 and 36 Township 40 Range 16, Sections 5-8, 17-21, 28, 29 and 30 Township 40 Range 15 and Sections 28, 29, 32 and 33 Township 39 Range 15 all West of the 4th Meridian.

Pursuant to section 73 of the Environmental Protection and Enhancement Act, any person who is directly affected by these operations may submit a written statement of concern regarding these applications. Failure to file a statement of concern may affect the right to file a Notice of Appeal with the Environmental Appeals Board. Such a statement of concern must be submitted to:

- He has been involved with SMRWSC since it started and with the Village of Veteran for 16 years.
- It was noted that John Van Doesburg, Earl Marshall, Wayne Richardson and Tim Fox have greatly assisted in the task of getting water from Stettler to Consort which has been well received.
- The Village of Big Valley was connected to the SMRWSC line in October, 2013.

- Construction is underway to hook the Village of Donalda up to the SMRWSC line.
- From this point funding may be frozen so further development will be on hold.
- The SMRWSC does plan and reserves will be put away for further upgrades and repairs.
- Next community to be serviced will be Monitor, Alberta, then White Sands and Rochon Sands as lines were placed to allow for future hook-ups.
- County of Camrose has a problem as Pelican Point is classified as a Hamlet, however, Alberta Transportation has indicated that they are not a Hamlet, therefore funding is jeopardized. This is an item that may require lobbying for funds.
- SMRWSC borrowing capacity is subject to Ministerial Approval.
