**Witness** that the County and the applicant agree as follows:

1. The applicant agrees to clearly mark the route to be plowed or graded so that the motor grader is not in danger of being damaged or of doing damage to property.
2. The County agrees to do the said undertaking providing that the applicant shall indemnify and hold harmless the County, its employees, officers and agents from any and all losses, costs, damages, actions, causes of action, suits, claims and demands resulting from anything done or omitted to be done by the County in the performance or purported performance of the said undertakings.
3. For snow removal from laneways, the applicant agrees to pay a non-refundable application fee of \$100 per season, prior to any inspections being completed or flags being issued. The applicant agrees to pay \$100.00 for the first ¼ mile and \$50 for each ¼ mile thereafter, per laneway, per occurrence.
  - For laneway snowplowing, a "flag" will be displayed where visible to the Grader Operator.
  - There will be no plowing to bins, haystacks or corrals.

- In Hamlets or Subdivisions there will be no snowplowing/grading services of driveways on private property.
4. For grading of laneways, the applicant agrees to pay a fee of \$100.00 for the first ¼ mile and \$50.00 for each ¼ mile thereafter, prior to the laneway being graded. Fee is per laneway, per occurrence.
